**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

**Applicability.** The Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

We will get board approval to remove 3 units from the 5h Plan and return them to public housing inventory to dispose of the units at Fair Market Value under Section 18 via open bid. The five units are scattered site units 009- 1105 Henry Street, 010- 1101 Henry Street, and 030- 904 S24th Street. SJHA will provide a project-based voucher HAP contract to the new owners of the three units.</p> <p>SJHA intends on designating some of its housing developments into Elderly / Disabled Housing. SJHA will continue to rehab units at one development with CFP funds, even if LIHTC and other funding sources are not obtained immediately. SJHA will continue to go after CDGB funds by partnering with the City of St Joseph and any other grants that can assist the Housing Authority in moving towards making these properties newer, fresher, and safer. SJHA has and will continue to review and revise the HCV Admin Plan and LIPH ACOP when needed or if any changes from HUD deems SJHA to review and change these policies due to Statutory or Regulatory Changes.</p>

SJHA continues to improve security by having all community rooms and hallway lighting has been switched to LED so as there are no dark areas at night for the common hallway buildings. SJHA has provided increased security at Pleasant Heights complex and updated all camera systems to gain additional recording times. SJHA will continue to apply for ESSG grants from HUD to add Cameras and Solar Lighting onto the properties to decrease dark areas, especially on exterior parking areas of the complex.
